

Public notification of decisions on the Proposed Whakatāne District Plan

The Whakatāne District Council gives notice that it has made decisions on the Proposed Whakatāne District Plan, in accordance with Clause 10 of the First Schedule of the Resource Management Act 1991.

Appeals to the Environment Court

Any person who made a submission or further submission may appeal to the Environment Court if:


- In relation to a provision or matter that is the subject of the appeal, the person referred to the provision or matter in the person's submission on the Proposed Whakatāne District Plan and;
- The appeal does not seek the withdrawal of the Proposed Whakatāne District Plan as a whole.

The statutory time limit for an appeal to the Environment Court is within 30 working days after the date on which the Council's decision on submissions and further submission is publicly notified. The date of public notification of the Whakatāne District Council's decisions is Friday, 4 December 2015. This means the final date for lodging an appeal to the Environment Court is Friday, 5 February 2016. The notice of appeal should be in the prescribed form, which is Form 7 of the Resource Management (Forms, Fees and Procedures) Regulations 2003. The address for lodging the appeal is:
